Disciplinary Infractions: 3 guilty in 24 years of a Life w/o Parole sentence

Letters of Protest: None, but many in favor of this action

Objections from Public Officials: Prosecuting Attorney and Sheriff

Findings: Victim was beaten to death with a pipe, allegedly after an argument with the victim ^{by this INMATE'S roommate} that is a real "stretch"

This inmate was charged for being an ACCESSORY. INFORMATION IN THIS INMATE'S FILE SHOW THAT HE HAD TWO (2) PRIOR FELONIES - THAT IS TOTALLY FALSE. THAT INFORMATION HAS APPARENTLY BEEN IN HIS FILE FOR A NUMBER OF YEARS, AND WAS MOST CERTAINLY IN THE FILE AS IT WAS REVIEWED BY THE PAROLE BOARD & TWO (2) GOVERNORS. UNDER "SUMMARY OF PRIOR CRIMINAL ACTIONS", IT STATES "JAMES WEAVER, WAS CONVICTED OF TWO (2) FELONY COUNTS OF THEFT OF PROPERTY, AND TWO (2) COUNTS OF BREAKING AND ENTERING IN PINE BLUFF, ARKANSAS, ON APRIL 13, 1988, AND WAS SENTENCED TO THREE (3) YEARS PROBATION AND THIRTY-TWO (32) HOURS". THOSE CRIMES WERE ALL ATTRIBUTED TO ALAN HUBBARD, ADC # 095183 WHO ACTUALLY KILLED THE VICTIM.
